Also, we have good news from the March 2016 Community Survey. Thank you to the twenty-six members who responded to the survey by both email and U. S. Mail, with your thoughts, observations and suggestions. From the results of the survey, projects are **already underway!** John Koontz and friends have already replaced the footbridge to the tennis courts on the Villas’ side of Wilton Coves Drive, on time and under budget!!! They plan to complete the second one shortly. **Great Big Thank You to John and friends!!!!**

The Board will be approving the members of the new Landscape Ad Hoc Committee at the next meeting. We already have a few volunteers for this committee; but, of course more would be greatly appreciated. What fun it would be to participate in the planning of the “New Look” for the Coves entrance and possibly a portion of Wilton Coves Drive (North). Lots of ideas have been suggested and the members of this committee will have the fun in making recommendations to the Board from these suggestions as well as the landscaping companies
